Demands: withdraw and apologise for the letter to the editor Remove final point on council further mandates a referendum

For: Fionn Sexton-Connolly, former class rep for BA Law, congratulate the cathaoirleach as a past cathaoirleach, important to support the motion and is sure that the exec will support, must affirm the rights of all trans people, the IT has acted as a partisan actor in many areas of Irish society, canvas the members of the exec and class reps that will be elected.

Clarification question: Hugh McArdle, 2nd year class rep Law and Human Rights not yet elected, unaware of controversery regarding IT and would like more information

Officer for LGBT: Over the past year, a movement has sprung up as a lot of people have realized that conversion therapy is still legal in Ireland, which is torture. Movement got much support, out of nowhere an article comes up from the IT, it essentially argued that banning conversion therapy would limit therapists ability to treat trans people – sees transgender people as something to be changed. Should not try to change someone for who they are – disgusting. Was on a panel for Galway Pride talking about conversion therapy, mentioned by most of the people that this article had been published. Have been other articles – similar lines of thought, transphobic thoughts, thought of TERF as a slur.

Point of order: Alexnder Sortov, 1st year Financial Maths not yet elected, have there been any other articles in the IT of similar content, was this an article of a letter to the editor? Officer: Should have prepared my research more solidly, I can send you a more detailed email later, don't want to give you an incomplete answer.

Criodan o murchu, research class rep: 3 specific articles the Trans Writer's Union, and two letters to the editor. Listed specific dates.

Fionn Sexton-Connolly, class rep presumptive for BA Law, will this be affected by the Student Union's Commercial Ltd?

Uachtaran: This is what this motion asks, also officer's refusal to engage with the Irish Times. We will stop selling or purchasing it in our services.

Point of Order: Uachtaran, IT is known to publish harmful articles for all types of minorities, such as travellers or minimalises SA to just sex. Will be considered when we vote on this next week.

Summate: Gender and LGBT+ rights officer – thanks everyone for their contribution, to the Uachtaran for expanding the scope beyond trans people, thanks to criodan for his research at the ready.

Amending the motion opposing fascism, extremism, and all forms of discrimination Officer for Gender and LGBT+ rights: Context – clarifying a motion which was passed last year. A lot of discussion surrounding this, was eventually 9c). Removed references to the far-right, also removed the list of groups which were deplatformed – became unclear as to who decides who gets deplatformed by this motion. All groups will not vindicate the rights of students, makes it unclear who the motion applies to. Potentially undemocratic situation. Council mandates that council decides who this applies to through dedicated motions. Further mandates a public list be made available and be updated on a regular basis on the CMLOEG website. Wants to clarify the motion, does not want to remove the previous motion. No point in adding a list at this stage, as council cannot vote.
